ABOUT THE ESSAY WRITING COMPETITION

The CFL, NLU Jodhpur, is proud to present the first edition of its Inter-College Essay Writing Competition on the theme of:

“Reproductive Rights & Bodily Autonomy.”

Examining the intersection of family law with questions of reproductive choice, bodily integrity, and evolving family structures is essential to understanding how legal systems shape and regulate intimate spheres of life. Further, exploring the ways in which reproductive rights and familial relationships interact with factors such as class, culture, gender, and access to healthcare reveals the various nuanced ways in which inequality, exclusion, and control remains obscured in narrower legal analyses.

Through this competition, CFL seeks to provide a platform for participants to engage critically with contemporary issues at the forefront of family law discourse. The competition aims to foster thoughtful and nuanced discussions on the evolving contours of family law, particularly in relation to reproductive rights, bodily autonomy, and diverse forms of family and kinship.

INDICATIVE SUB-THEMES

The theme of “*Reproductive Rights and Bodily Autonomy*” encompasses a wide range of legal, social, and ethical issues that shape individual agency and family relationships.

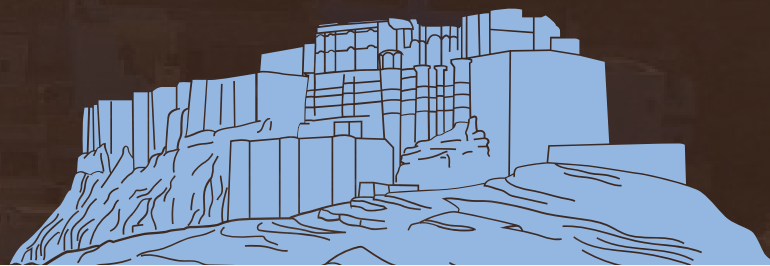
To guide participants, the following indicative sub-themes are provided:

- *Abortion: Reproductive Choice and State Control*
- *Female Genital Mutilation: Bodily Integrity*
- *Surrogacy and Assisted Reproductive Technology (Regulation) Act, 2021: A Critical Analysis of the Regulatory Framework*
- *Maternal Health and Post-Partum Care: Rights, Access, and Challenges Child Marriage and Reproductive Autonomy*
- *Child Marriage and Reproductive Autonomy*

Participants are encouraged to explore these themes from interdisciplinary and critical perspectives.

The above list is merely indicative and not exhaustive.

REGISTRATION PROCESS

Participants are required to complete the registration process before submission. The registration fee shall be as follows:

- Submissions by a single author: Rs. 300/-
- Co-authored submissions (*maximum 2 authors*): Rs. 600/-

Payment is to be made on the following Payment Link (Click [here](#)).

Note: Payment for both co-authors is to be made by one person.

After completing payment, a clear screenshot or photograph of the payment receipt must be uploaded along with relevant details on the following Registration Link (Click [here](#)).

SUBMISSION GUIDELINES

Submissions must be made in **Microsoft Word format** (.doc or .docx) on the google form link that shall be circulated later.

- Co-authorship of up to **two (2) authors** is permitted.

The word limit for the essay submission is **2,500–3,000 words**.

Anonymity: Disclosure of information regarding the identity of the author(s), including but not limited to name, institutional affiliation, or professional details in the manuscript, is prohibited.

Originality: Submissions must be original and unpublished work of the author(s). Authors shall be solely responsible for ensuring the accuracy of the facts, authorities, and opinions expressed in their submissions.

- All submissions will be screened for **plagiarism**. Manuscripts with a similarity index exceeding 15% will be summarily rejected.

Referencing: wherever possible, references must be incorporated through hyperlinks within the text. Where an online source is unavailable, footnotes may be used. All footnotes must conform to the Oscola Citation Style.

Formatting Guidelines: Garamond font; Size 12 for the main text and Size 10 for footnotes; Justified alignment; 1.5 line spacing for the main text and single spacing for endnotes.

- Verbatim quotations must be enclosed within double quotation marks and appropriately italicised.

REVIEW PROCESS

To ensure fairness, transparency, and academic rigour, all submissions will undergo a **multi-stage review process**.

Stage I: Technical Screening

Upon receipt of submissions through the designated Google Form, all entries shall undergo an initial compliance review. Submissions will be screened for adherence to the competition guidelines, including formatting requirements, anonymity standards, plagiarism thresholds, and originality requirements.

As specified in the Submission Guidelines, entries with:

- a plagiarism score exceeding 15%,
- or any detectable use of generative artificial intelligence tools,

shall be disqualified and will not proceed to the substantive evaluation stage.

Stage II: Editorial Review

Submissions that successfully clear the technical screening stage shall be evaluated by the Editorial Board of the Family Law Chronicle. The Editorial Board will assess entries on the basis of the various evaluation parameters, including originality, quality of research, depth of analysis, structure, coherence, and contribution to contemporary discourse on family law.

Based on the cumulative scores awarded during stage II, the Top Ten submissions shall be shortlisted for the final round of review.

Stage III: Faculty Review and Final Adjudication

The shortlisted submissions shall be forwarded to an independent panel of faculty reviewers possessing expertise in family law, constitutional law, gender studies, and allied disciplines.

The faculty reviewers shall independently evaluate the shortlisted entries and determine the final rankings. Based on their assessment, the **First, Second, and Third Position Winners** shall be selected.

Please note that the decision of the reviewers shall be final and binding.

Special Recognition

In addition to the winning entries, the Review Board may, at its discretion, consider entries for publication in the Family Law Chronicle, subject to editorial review and publication standards.

PANELISTS' PROFILES

The final round of evaluation shall be conducted by an esteemed panel of faculty members from NLUJ, whose scholarship and expertise span the fields of family law, constitutional law, gender studies, and socio-legal research.

DR. ASHA BHANDARI

Dr. Asha Bhandari is an Associate Professor of Humanities and Social Sciences at NLUJ. Her academic interests include Gender Studies, Legal Reasoning, and interdisciplinary approaches to law & society.



DR. SAYANTANI BAGCHI

Dr. Sayantani Bagchi is an Assistant Professor of Law at NLUJ. Her research and teaching primarily focus on Constitutional Law, with a particular interest in Rights–Based Jurisprudence and contemporary constitutional developments.

Dr. Rahsmi Mathur is an Associate Professor of English at NLUJ. Her areas of interest include Language of Law, Modern Feminism, Post-colonial writing and Intersectionality.
