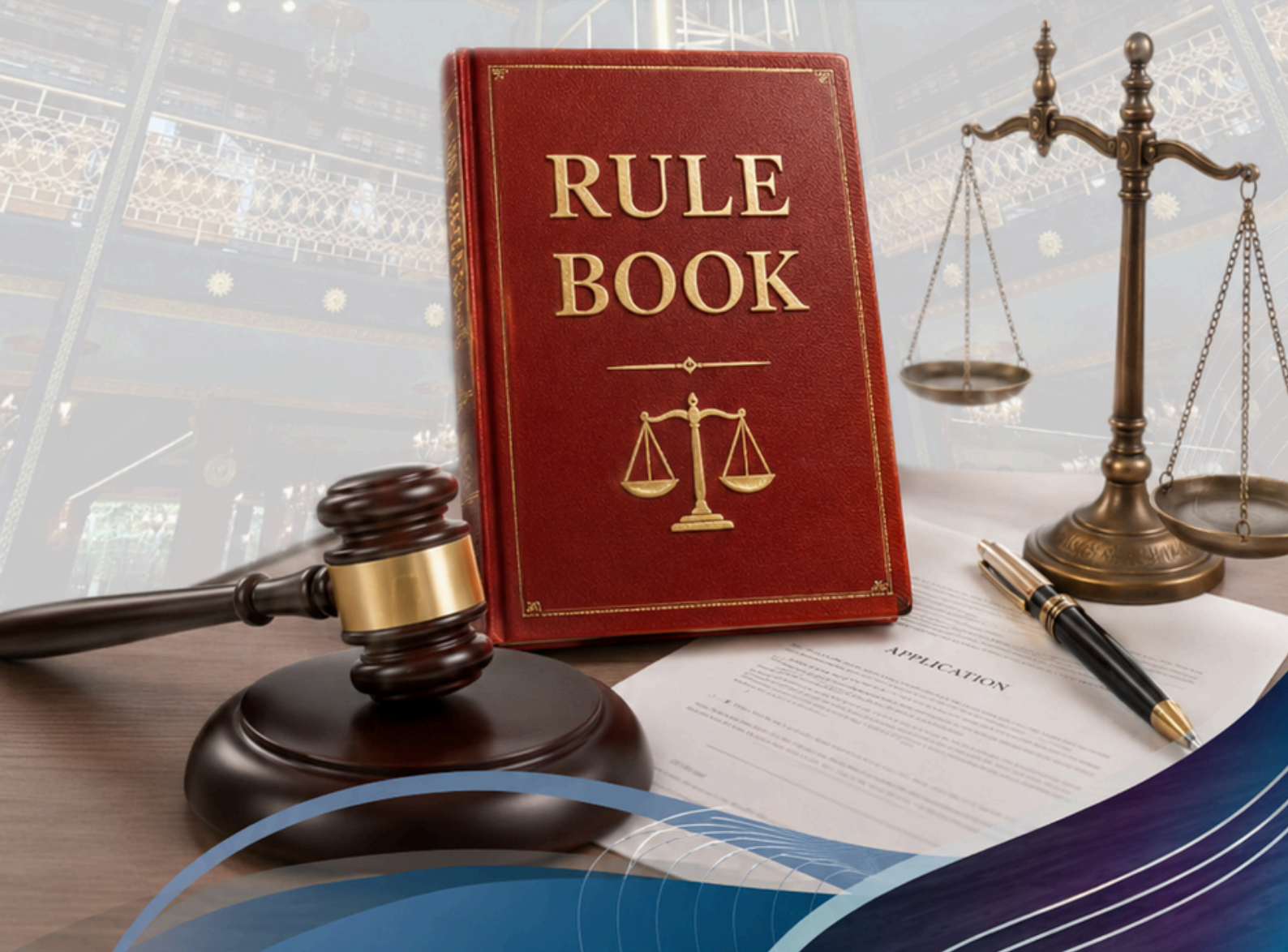

COMPETITION FORMAT

1. A factual criminal law proposition shall be provided to all participants on the date of the competition.
2. Participants are required to draft a:
 - Regular Bail Application, or
 - Anticipatory Bail Application as specified in the proposition.
3. **Drafting must include:**
 - Cause title
 - Relevant provisions of law
 - Facts of the case
 - Grounds for bail
 - Prayer clause
 - Verification, if applicable
4. **Maximum length:**
 - 5 pages excluding cover page.
5. The document must not contain:

Any mark of identification except the participant's registration details where instructed.
6. Late submissions shall not be accepted under any circumstances.

8. SUBMISSION GUIDELINES

1. The submission must be made in:
 - **PDF format only.**
2. File name format:
 - **ParticipantName_CollegeName.pdf**
3. The draft must:
 - Be typed in **ENGLISH** only.
 - Use **Times New Roman, Font Size 12.**
 - Use **1.5 line spacing.**
4. Maintain proper margins and formatting.

9. EVALUATION CRITERIA
