ABOUT THE CONFERENCE

The increasing integration of science and technology including artificial intelligence (AI) and digital technologies is significantly reshaping criminal justice systems across the world. Their growing application and use in areas such as policing, investigation, adjudication has become central to contemporary administration and governance. The integration of technology enhances efficiency, improves investigative capabilities, strengthens evidence collection, facilitates judicial administration, and helps to address and combats enhanced forms of cyber and transnational crime.

While these technological developments increase efficiency, accuracy, and institutional effectiveness, they also raise serious concerns relating to privacy, human rights, fairness etc. These challenges call for a robust legal reform to govern the use of emerging technology in criminal justice systems.

Globally, policymakers and juridical institutions are attempting to develop appropriate regulatory frameworks that balance technological innovation with human rights, justice and values. Multiple International organisations have increasingly emphasized the need for responsible governance of emerging technologies in law enforcement and criminal justice systems. In India, recent legislative reforms, including the Bharatiya Nyaya Sanhita, Bharatiya Nagarik Suraksha Sanhita, Bharatiya Sakshya Adhiniyam of 2023 and the Digital Personal Data Protection Act, 2023, and evolving cybersecurity frameworks have further intensified scholarly discourse on technology-driven criminal justice reforms.

In this context, Xavier Law School, St. Xavier's University, Kolkata proposes to organise a **Two-Days International Conference on "Emerging Technologies in Criminal Justice Administration: Challenges and Opportunities"** on 14th and 15th January, 2027. The proposed conference aims to provide a platform to critically engage with the opportunities and challenges posed by these scientific developments, especially concerning fairness, privacy, accountability, human rights, and regulatory governance. It seeks to bring together scholars, practitioners, policymakers, civil society organisations and students and provide them an opportunity to have a dialogue and critically discuss emerging trends and future directions in criminal justice. SUBMISSION GUIDELINES

Given below are important Submission Guidelines mandatory for every Participant to comply with.

1. Participants are required to submit their abstract in accordance with the prescribed deadline ie by 3rd of October, 2026.
2. Authors of shortlisted abstracts will be notified of their acceptance via email by 10th of October, 2026.
3. After intimation of acceptance of abstract, participants are required to register through the link and upload the full paper the proof of payment.
4. Registration is mandatory for each author/co-author.
5. In case of non-registration and non-payment of fees by the co-authors, they shall not receive the certificate of presentation and there their names shall be removed from the abstract book and conference schedule.
6. No in absentia presentation certificate shall be provided in case no author/co-author is present (online or offline).
7. Certificates will be issued individually to each registered authors. Requests relating to certificates will be entertained only within one month from the date of conclusion of the Conference.
8. Full papers submitted adhering to the submission guidelines will be accepted for presentation.
9. The paper must be submitted only in Microsoft Word format.
10. Co-authorship is allowed only up to two authors.
11. All submissions must have an appropriate article title which is different from the theme.
12. The maximum word limit of the article must be 3500 - 4500 words, excluding footnotes.

MANUSCRIPT GUIDELINES

The manuscript shall be accompanied by a cover page containing details such as

TITLE OF THE PAPER:

1. Theme of the Paper,
2. Name of the Author and Co-author (if any),
3. University/ Institution/Organization,
4. Email Address and Mobile Number.

FORMATTING REQUIREMENTS:

1. Font: Times New Roman
2. Main Text: Size 12
3. Footnotes: Size 10
4. Paper Size: A4
5. Margins: 2.54 cm (Normal)
6. Alignment: Justified throughout
